3. Question: Are an Internal Revenue Service (IRS) Employer Identification Number (EIN), also known as the Federal Tax ID number, a Dun & Bradstreet Dun Number (D-U-N-S® also known as DUNS#), and a Federal System for Award Management (SAM) Unique Entity Identification Numbers (UEID #) required to be submitted with the Request for Proposal (RFP) response submission?

Answer: The EIN and DUNS numbers are sufficient to submit with your RFP response; however, as with the DC Certificate of Clean Hands, the UEID number must be provided for required compliance checks prior to any potential contract award.

4. Once we upload the files, does DCRB have access to those files? Or is there another step we need to take? I see that I can invite people in the app to view the files (by email address), or I can create and share links to the files and share them by email myself. We do not see an option to upload our proposal from our box account to the DCRB landing page.

Answer: DCRB has access to the files uploaded to the Drop-Box RFP location. The other options for submitting your proposal are as noted and for back-up if needed. Although the solicitation is posted on the DCRB website, there is no option to upload the RFP submission at the website location. There is no option to upload a proposal from a potential offeror's drop box account to the DCRB website.

Options for RFP response submission are:

- a) Upload to the solicitation Drop-Box location,
- b) Share links created via the Drop-Box solicitation and share links the links to your RFP submission files with albert.walker2@dc.gov,
- c) Send the RFP submission files via email to albert.walker2@dc.gov and dcrb.procurement@dc.gov.

Note: All amendments issued in reference to the solicitation must be signed and submitted with the RFP proposal submission to acknowledge receipt of the amendment.
