Chair Bress introduced the Bolton team, to provide the Board with the results of the 2023 Actuarial Valuations for approval. Ann Sturner, Bolton, went over the key results in the report. Trustee Danny Gregg noted for the record that this report was presented to a majority of the trustees at the last Operations Committee meeting in great detail. Chair Bress noted that the city's contribution to the plans is increasing this year due to retroactive salary increases negotiated by the unions and the city. He also noted that DCRB is still recognizing investment losses from previous years as a result of the actuarial smoothing process. Although the Board is not involved with the negotiations with the union for increases, the city considers that the retroactive and prospective raises negotiated will result in contribution increases to the retirement plan.

Trustee Collins asked if there is anything pending before the City Council on behalf of the Police, Fire and Teachers that could have impact on what the actuarial valuation report reflects. Trustee Lyle Blanchard responded that he is not aware of any bills that will impact the Police, Fire or Teachers' Plans.

Chair Bress made a motion to accept and approve the FY2023 Actuarial Valuations Report.
