## **APPROVAL OF MINUTES**

### **INVESTMENT COMMITTEE REPORT**

Ms. Blum, Committee Chair, made the following motions:

<u>Motion #2</u>: To grant Investment Managers full investment authority and discretion to trade in certain derivative instruments as set forth in their contractual agreements. The motion was approved by a voice vote of 8-1.

<u>Motion #3</u>: To establish a futures account subject to contract negotiations. The motion was approved by a voice vote of 9-0.

## **OPERATIONS COMMITTEE REPORT**

Ms. Marcus, Committee Chair, made the following motions:

<u>Motion #4</u>: To permit qualified voters to cast their ballots electronically in the 2008 Retired Police Officer and Active Fire Fighter elections. The motion was approved by a voice vote of 9-0.

**Motion #5:** To change the practice of collecting member data for the annual actuarial valuation of the retirement plans from "as of September 30" to "as of June 30", as recommended by EFI, the Board's actuary. The motion was approved by a voice vote of 9-0.

**Motion #6**: To renew the Board's fiduciary liability insurance policy. The motion was approved by a voice vote of 9-0.

# LEGISLATIVE COMMITTEE REPORT

Mr. Blanchard, Committee Chair, stated that a public hearing is scheduled for October 8, 2008, on the "Prohibition of the Investment of Public Funds in Certain Companies Doing Business with the Government of Iran Act of 2008" (B17-657).

**Motion #7:** To approve the mission statement, as amended, to include the following sentence: The District of Columbia Retirement Board's mission is to prudently invest the assets of the Police Officers, Firefighters and Teachers of the District of Columbia while providing those employees with total retirement services. The motion was approved by a voice vote of 9-0.

Ms. Collins, Committee Chair, gave the following status report on current projects: the scanning project, feasibility study, technology roadmap and EMS/Fire consolidation projects are all on schedule; the split benefit reconciliation project is ongoing.

**Motion #8:** That the Board's Executive Director and General Counsel continue to work with the Mayor of the District of Columbia to resolve the teacher plan correction issue. The motion was approved by a voice vote of 9-0.
